1. Prefinished Gypsum Board: Gypsum core wall panel surfaced on front and long edges with vinyl and complying with ASTM C 1396 (Gold Bond® 1/2" Durasan® Prefinished Gypsum Board).
  - a) Thickness: 1/2 in.
  - b) Width: 4 ft.
  - c) Length: 8 ft. through 14 ft.
  - d) Edges: Beveled.
2. Fire-Rated Prefinished Gypsum Board: A gypsum core wall panel with additives to enhance fire resistance of the core and surfaced with vinyl on front and long edges and complying with ASTM C 1396, Type X (Gold Bond® 5/8" Durasan® Prefinished Gypsum Board).
  - a) Thickness: 5/8 in.
  - b) Width: 4 ft.
  - c) Length: 8 ft. through 14 ft.
  - d) Edges: Beveled.

### B. Panel Covering:

7. Nails: Painted stainless steel with a shank dia. of 0.145 in. and diamond embossed head, Color Pins.
